GENERAL INFORMATION

Profile Description and Purpose

Released in 2004, the *Developmental Assets Profile* (DAP) is based on Search Institute's Developmental AssetsTM framework, a strength-based approach for promoting the healthy development of children and youth. The framework defines the relationships, opportunities, skills, and values children and adolescents need to thrive.

The DAP is designed to provide a standardized description of an adolescent's Developmental Assets within the context of the four External Asset Categories (Support, Empowerment, Boundaries and Expectations, Constructive Use of Time), the four Internal Asset Categories (Commitment to Learning, Positive Values, Social Competencies, Positive Identity), as well as within five social contexts (Personal Assets, Social Assets, Family Assets, School Assets, and Community Assets).

DAP Options

The DAP has two options, one for individual assessment and one for group assessment. The individual assessment option is intended for qualified clinicians, school counselors, mental health practitioners, and clinical social workers. The group assessment option is appropriate for youth programs in schools, juvenile justice, mental health, and family services settings.

Search Institute has established qualification guidelines for users of the DAP to ensure its appropriate use by professionals who are trained and experienced in the use of individual and small group assessment instruments. Qualification requirements differ according to whether the instrument is to be used as a group measure or as an individual assessment tool.

User Qualifications

Individual Assessment Qualification Requirements

1. Familiarity with Search Institute's Developmental Assets framework,
2. Master's degree in Psychology, Education or related field, and
3. Certification of licensure in a professional field which requires training and experience in the ethical and competent use of psychological tests.

Group Assessment Qualification Requirements

1. Familiarity with Search Institute's Developmental Assets framework,
2. Master's degree or equivalent experience in a related field,
3. Basic understanding of survey administration, data analysis and data interpretation, and
4. The ability to conduct statistical analyses of group differences.

Qualification Requirements for Use of the DAP for Research Purposes

1. Familiarity with Search Institute's Developmental Assets framework, and
2. Ph.D. or equivalent degree in psychology, sociology, education, or related field.

Qualification Requirements for Use of the DAP for Research Purposes by Students/Trainees

1. Familiarity with Search Institute's Developmental Assets framework, and
2. Supervision and research oversight by Ph.D. or equivalent level researcher in the area of psychology, sociology, education, or related field. If individual assessment is intended, the supervisor must be qualified as an individual assessment user (see above for requirements).

You will notify us in writing if the person listed and approved on the Statement of User Qualifications ceases to have direction and control over your use of the DAP for any reason, and you will suspend your use of the DAP until a substitute employee or contractor has submitted a Statement of User Qualifications and has been approved by us.
